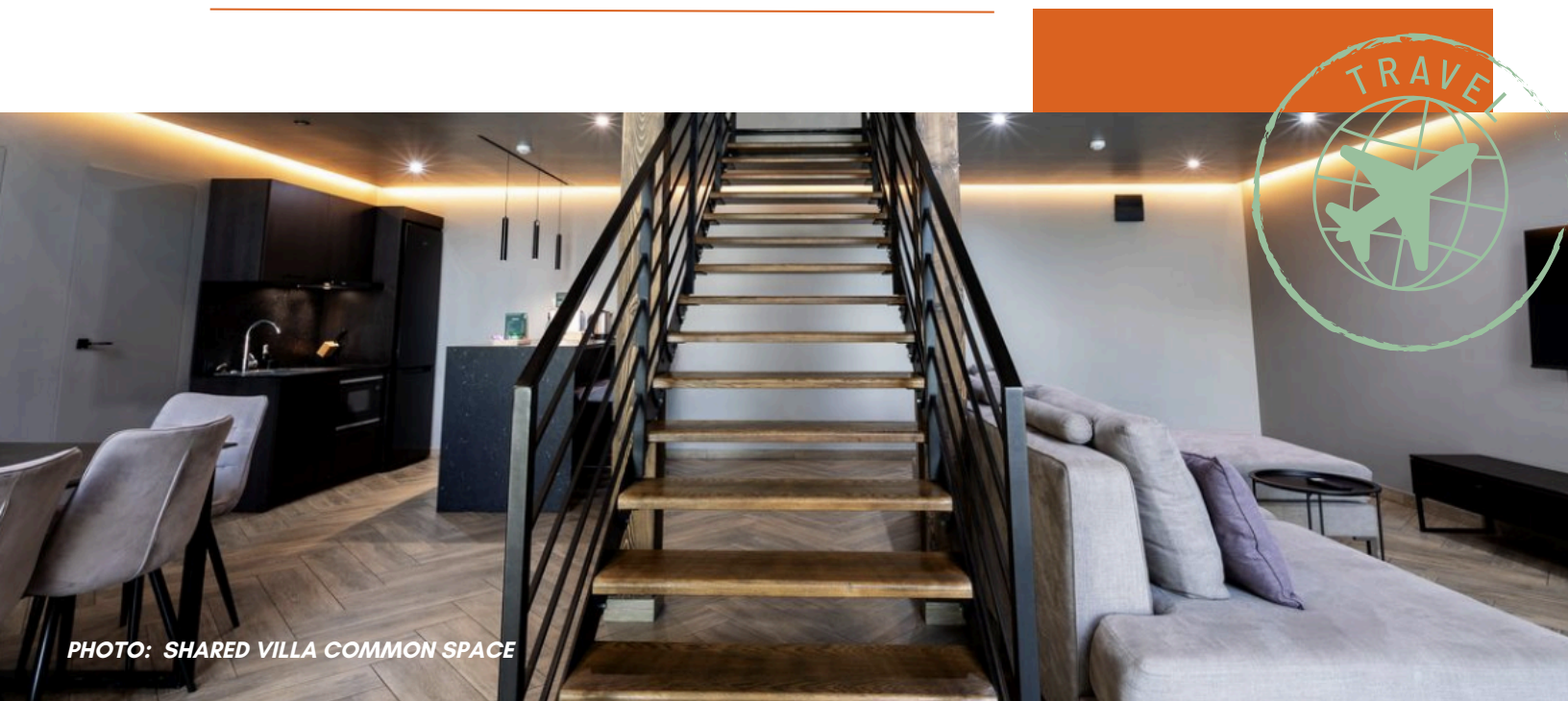

# BOOKING AGREEMENT

This Booking Agreement outlines the terms and conditions for joining the Mending Miles Co. Moldova 2026 retreat ("the Experience"). By submitting a booking request, making any payment, you ("Participant") agree to all terms below.

## 1. EXPERIENCE OVERVIEW

The Moldova 2026 Experience is a curated cultural, gastrocultural, and introspective travel program for women. The total cost of participation is **\$4100 USD per person.**

---

## 2. PARTICIPANT ELIGIBILITY & INTENT OF SPACE

This retreat is designed for women who feel aligned with women-centered spaces and who thrive in environments created for connection, reflection, and emotional safety. Participation is reserved for individuals who are comfortable engaging in a women's co-living experience.

---

## 3. WHAT'S INCLUDED

- Six nights in a private room within a shared villa
- All scheduled meals as outlined in the itinerary, including 2 meals on arrival day, 3 meals per full Experience day, 1 meal on departure day, plus shared snacks, breakfast items, and convenience items
- All cultural tours, group sessions, and curated dining experiences listed in the itinerary
- All group transportation for scheduled activities
- Airport pickup on arrival day and airport shuttle on departure day
- Access to sauna, swimming areas, and shared villa amenities



#### 4. WHAT'S NOT INCLUDED

- Flights to and from Moldova
- Travel insurance
- Visa fees, if applicable
- Medical care or emergency expenses
- Meals, drinks, and transportation not listed in the itinerary
- Lodging or transportation for early arrivals or late departures
- Personal purchases, additional services, or optional activities

---

#### 5. ACCOMMODATIONS & CHECK-IN/CHECK-OUT

- Check-in begins at 3 PM on arrival day
- Check-out is 8:00 AM on departure day
- Participants arriving earlier or staying later must arrange their own lodging and transportation
- Shared villa with shared amenities and private rooms for all participants
- Participants agree to respect all shared spaces and maintain reasonable cleanliness

---

#### 6. FOOD, DINING & ALLERGENS

- All meals are shared dining experiences
- Some dietary restrictions may not be possible to accommodate
- The allergen sheet is informational only, and menus cannot be customized
- Cross-contamination cannot be completely prevented
- Participants with allergies and dietary restrictions assume full responsibility for their dietary safety

---

#### 7. RESPECT & SAFETY CLAUSE (CO-LIVING ENVIRONMENT)

To maintain a peaceful and supportive environment, Participants agree to:

- Treat everyone with kindness and respect
- Respect personal space and boundaries – enter private spaces only when explicitly invited to
- Honor quiet hours and house guidelines
- Keep shared areas clean and cared for
- Guests are not allowed in the Villa
- Consume alcohol responsibly
- No vaping indoors in shared spaces, and smoke only in designated outdoor areas

Violation of these expectations may result in removal from the Experience without refund.



## 8. PHYSICAL ABILITY & PERSONAL RESPONSIBILITY

- The retreat includes walking tours, gentle hikes, and full days of activity
  - Participants are responsible for assessing their physical readiness
  - Sauna and swimming areas must be used safely and responsibly
  - Participants must not engage in any activity they are untrained for
  - Participation is voluntary, and individuals assume all personal risk

## 9. LEGAL REQUIREMENTS & ZERO-TOLERANCE POLICIES

- Participants must follow all Moldovan laws and the rules of all visited venues
  - **Zero-tolerance drug policy**
  - Excessive intoxication or unsafe behavior is prohibited
  - No weapons are allowed while staying at the Villa
  - Harassment, aggression, or threatening behavior will result in police intervention and expulsion from the Villa
  - Violation of any safety rule will result in immediate expulsion + Police intervention

## 10. PROPERTY & VEHICLE DAMAGE RESPONSIBILITY

Participants are financially responsible for any damage they cause to:

- The villa or its furnishings
- Shared amenities (sauna, pool, appliances, fixtures, décor)
- Vehicles used during transportation
- Third-party property at tours, activities, or partner locations

Participants must report defective appliances or damage immediately and cover the repair or replacement costs when responsible for the damage.

---

## 11. PAYMENT TERMS

- A 50 percent non-refundable deposit (\$2050) plus a signed booking agreement are required to secure your spot.
- Spots are first-come, first-served and cannot be held without payment.
- The remaining 50 percent (\$2050) is due 40 days before the start of the retreat (Saturday, March 14th, 2026), all payments are nonrefundable.
- An invoice to complete your booking will be sent to the email provided following your deposit payment and signed booking agreement.



## 12. REFUNDS & CANCELLATIONS

- The 50 percent deposit is nonrefundable.
- All payments become non-refundable 39 days before the retreat.
- If the remaining payment is not received 40 days before the retreat, your spot may be released.
- Exceptions **can't be made** for illness, emergencies, or travel disruptions.
- Participants must use their travel insurance for any losses or reimbursements.

## 13. GROUNDS FOR REMOVAL

Mending Miles Co. reserves the right to remove a Participant without refund for:

- Failure to follow Moldovan laws & Zero drug tolerance policy
- Unsafe alcohol use or intoxication
- Possession or use of illegal substances
- Harassment, aggressive behavior, or threats
- Bringing guests into the villa
- Disrupting group activities or compromising emotional safety
- Refusal to follow instructions from hosts or facilitators

## 14. AGREEMENT TO THESE TERMS

By submitting a booking request and paying your deposit for participating in the retreat, you confirm that you:

- Have read and understood this Agreement
- Agree voluntarily to all terms
- Accept all personal risk associated with travel and participation
- Understand that this is a women-centered, co-living, introspective experience
